1. Athlete Tracking Discussion: Dave Stiles (RACC) has introduced new athlete tracking software for the 2017-2018 season. Level reps will use reports for compiling information for state functions.
2. State Funds Discussion: Current balance for Indiana USA Gymnastics \$48,809.09
3. Training Camp Discussion: All registered athletes for training camps will receive a free t-shirt.
4. Regional Leotard Discussion: 2018 regional leotard color will be turquoise. State committee will accept bids for leotard vendors.

5. Judges Discussion – If there is not a sufficient number of judges available from Indiana to cover 3 designated local meets per weekend.

6. Indiana State Congress Discussion:
 - a. Additional tracks to be offered. Development, Optional, Judges, Recreational/Pre-School and Business.
 - b. Registration cost for 2018 Indiana State Congress will be \$200.00 per club which will include 6 registrations into State Congress. Additional registration will be \$30.00 each
7. State Meet Discussion: 2018 Indiana State Meet judges will be assigned on Friday, November 10th, 2017 for Levels 2/3 and Level 4/5. Xcel and Optional will be assigned after Regional judges assignments are announced.
8. Indiana Rules & Policies Clarification: Team Ties:
In the event of a tie for team awards: Both teams will be recognized as a tie. Based on traditional tie breaking procedures, the team with the highest event score will take home the team award and a duplicate award will be ordered and delivered to the other team.
9. Indiana Rules & Policies UPDATE: Declaration date for athletes: January 1st for all compulsory athletes and registration deadline for all optional and XCEL athletes.
